5	Secretaries Reports 5.1 General Secretary – CAM reported <ul style="list-style-type: none">- FA guidance has been received regarding grass roots football which has been disseminated via Somerset County FA (SFA) to all Clubs.- YDFL App recently experienced a technical issue causing minor difficulties however, the matter has been corrected. Users should click the refresh button when the App is opened to re-boot.- Trophy return – Trophies due to be returned for cleaning and engraving will be recalled by the end of January 2021.- Cancelled fixtures approved at the Nov Meeting will receive the fine following this Meeting, as it was deemed unfair to issue a fine when football was in lockdown and Clubs would have little income. Sponsorship <ul style="list-style-type: none">- Meetings are to be arranged for Sponsors whose Cup Competitions were played for Season 2019/20.	

5.2	<p>Junior Fixtures Secretary –</p> <ul style="list-style-type: none"> - Teams cancelling matches due to Covid-19 are being requested to present evidence of test results. - With the increased delays to fixtures, it is still intended for the Premier League to be completed by the end of January 2021 and the other Divisions by mid-March 2021, to allow Cup Competitions to be played. - Approximately 50% of fixtures have been completed.
	<p>Covid-19</p> <p>Some Teams and Referees are isolating due to positive Covid-19 testing. The Meeting discussed the option to cancel all matches until the weekend of Jan 02, 21 to prevent Christmas isolations.</p>
	<p>Concern was expressed for the number of schools around the district, in which whole year groups are isolating due to suspected/confirmed Covid-19.</p>
	<p>It was decided that in the best interests of all our Clubs, players and officials, all matches throughout the Yeovil & District League scheduled for this coming weekend would be postponed. We recognise that there is currently a local spike in the SARS-CoV2 virus causing a number of positive test results for COVID-19. A number of players in the Junior League, and more principally in the Youth and Mini Leagues, as well as two referees, have all tested positive in the last week.</p>
	<p>We realise this may be a disappointment and inconvenience for some, which is regrettable, but the implications of any players being in contact with someone who subsequently tests positive would be self-isolation for all players and officials involved in the game, as well as their families, over the Christmas period. This is a risk we do not feel can be justified.</p>
